The professional will be accountable for monitoring industry issues and trends, political and legal actions, participating in local, regional and state level public policy discussions and working to promote and ensure outcomes that will provide a solid economic and physical infrastructure for quality growth and robust economic prosperity.

Qualifications. Candidates for the Director's position should possess a Bachelors degree with major course work in public policy, planning, real estate, government affairs, and/or business. A graduate degree and three years of equivalent experience is preferred. Professionals applying for the position should have or can obtain a valid Georgia drivers license within 30 days of being selected for the role. Applicants should also be authorized to work within the United States.

Office Location and Travel. The Director will be based in the offices of the Council which is located on Peachtree Dunwoody Road at the intersection of Interstate 285. Candidates should live within a reasonable commuting distance of the offices. Travel in the metro Atlanta area is significant for the position. There will be early morning and evening events that require the Director's attendance.

Key Responsibilities. Building relationships with elected officials, citizen advisory groups, policy makers and other industry, business and environmental organizations who have a focus on the metro Atlanta region is essential to the success of the Director and the Council.

Another significant responsibility of the professional is the development and execution of the Council's legislative agenda at the Georgia General Assembly. The Director will serve as a registered lobbyist for the organization, using strategic partnerships to further the standing of the Council.

Emerging Leaders Initiative

The Director will spearhead the Emerging Leaders Initiative of the Council. ELI members explore the growth and development industry through events hosted and led by senior executives and leaders from engineering companies, developers, law firms, CIDs, utilities and other industry sectors, including federal, state and local government officials. Through the Director's involvement in ELI, the professional has the opportunity to meet many of the future decision-makers of metro Atlanta.
