Other organization accountable duties for the President include financial growth and management, talent development, communications, government relations/public policy, and building partnerships for economic, community and regional development.

The search process was divided into three segments. The first phase included conversations with various stakeholders in the area and listening to their thoughts on character traits required of the new leader. The second segment focused on identifying candidates who met the Search Committee's criteria through a nationwide search. Finally, the committee initiated a vetting process to include a detailed application and in-person interviews to learn more about the most qualified candidates
